SHOW RULES AND REGULATIONS

APPLICABLE TO ALL BREEDS UNLESS OTHERWISE INDICATED

Exhibitors are urged to acquaint themselves with these rules and regulations of the Show.

1. CLOSING DATES - NO LATE ENTRIES WILL BE ACCEPTED!

2. ENTRIES

- Only legible entries on the Show's official entry forms will be accepted. PLEASE PRINT.
- Unsigned and incomplete entries will not be accepted - NO EXCEPTIONS.
- All entry forms can either be e-mailed or faxed directly to the Breed Representative.
- Separate entry forms must be completed for each breed, e.g. if you enter into the "General Breed" and the "Appaloosas", separate forms MUST be used.
- No animal names to be used with the PAYMENT REFERENCES as this makes reconciliation extremely difficult. Please use exhibitor's and breed's name for easy identification e.g. SMITH, PINZGAUERS.

3. MINIMUM ENTRIES

- The Show Organisers reserve the right, after the entry closing date, to cancel a particular breed's show due to insufficient entries/numbers. If any cancellations occur due to insufficient numbers, full entry fees will be refunded to exhibitors.

4. ENTRY FEES

- Proof of payment must accompany entries and must be forwarded to the Breed Convenor.
- The Show takes no responsibility for any payments lost in the post.
- No refund of entry fees for late cancellation from exhibitors will be allowed. Minimum period allowed for late entry cancellations is 30 days prior to the Show date.
- Cancellations will only be accepted in writing.
- Only in extreme cases such as the death of an animal or injuries sustained, will a shorter cancellation period be applicable (see 6. below).

5. PAYMENTS

- Payments should be made to the Breed Society. Please contact your Breed Convenor.
- Proof of payment must reflect legible, identifiable details, e.g. name of exhibitor, breed and cell number.
- NB : When paying for entries in multiple breeds, please specify payment breakdown clearly.

6. CANCELLATIONS AND REFUNDS

- Written cancellations must be submitted immediately and will be accepted 30 days before closing date and in exceptional cases, e.g. death or injury of animal, one week after closing date.
- Cancellations received after the closing date will be subject to a 30% cancellation fee. Stable fees will be retained and the balance of the entry fee will be repaid one (1) month after closing date of the Show. This request must be submitted to your Breed Convenor.
- Replacements are permitted up to 21 days before the closing date. The Show Organisers need to be notified of such replacement/s by submitting a replacement entry form.

7. PRIZE MONEY

- **CATTLE** - As agreed with the Committee Members.
- **EQUINE** - As agreed with Committee Members.
- **GOATS** - As agreed with Committee Members.
- **SHEEP** - As agreed with Committee Members.
- **POULTRY** - As agreed with Committee Members.
- **FANCY PIGEONS** - As agreed with Committee Members.
- **RABBITS** - As agreed with Committee Members.

8. VERY IMPORTANT NOTICES

- **CATTLE** - All animals must be TB and BM-free certified. All entries will be inspected by the state veterinarian. If there is any doubt or queries, the veterinarian will contact the exhibitor personally.
- **CATTLE** - It is imperative that the certificates accompany your entry. If despatch is not possible or if there is a problem obtaining these certificates on time, arrangements need to

be made with Hester at hester@jacarandaevents.co.za, cell no 0826913019, or with the veterinarian or alternatively, leave a copy with a responsible team leader. Animals entering the Show premises without the certificates without prior arrangements with Hester Ingamells or the state veterinarian, will not be permitted to participate in their breed's show.

- **CATTLE** - the age of the animal is determined as at 1 August 2014.
- **HORSES** - All animal passports must be stamped with the necessary vaccinations.
- **ALL OTHER SMALL LIVESTOCK** - All the necessary travel documentation should be made available for inspection by the state veterinarian.
- **ALL OTHER SMALL LIVESTOCK** - All exhibitors must bring their own water and food bowls for their animals.

9. INSURANCE

- All exhibitors must provide their own public liability insurance and medical insurance.

10. LIABILITY CLAUSE

This event is hosted under the auspices of the breed societies/clubs whereby the Organisers of the Jacaranda Agricultural Show only act in an administrative capacity. The Jacaranda Show cannot be held responsible for any loss whatsoever arising from the cancellation, postponement or adjustment of the event. The Jacaranda Show, its directors, representatives, employees, agents and contractors will not be held responsible for any personal injuries or death of any person/s, loss or damage to any property of any kind, no matter how they arise and whether the injury, death, loss or damage was caused by the failure or negligence of any kind of the aforementioned parties or persons or otherwise.

11. ARRIVAL AND DEPARTURE PROCEDURES

- Exhibitors are requested to inform the breed convenor of their arrival and departure times and these times need to be strictly adhered to.
- Early arrivals and late departures will only be permitted once permission has been granted by Show Organisers and breed convenors.
- On entry at Gate P7, all exhibitors can collect their envelopes with entry and parking tickets.

12. STABLES

- All stable requests must be indicated on entry forms. Preference will be given to exhibitors who are travelling from far. Requests for additional stables will be subject to availability.
- Rooms for handlers are not guaranteed but will be considered on availability and it will only be considered on a "share" basis.
- Bedding for stables can be purchased during the Show. A receipt will be issued for the purchase of bedding.
- The Show Organisers accept no responsibility for any possible loss or damage to any entrants/handlers' property.

13. SAFETY AND FIRE REGULATIONS

- It is the exhibitor's responsibility to ensure that the fire equipment/water pipes at the stables are not used to wash their animals with or give them water. ANY ABUSE BY ANY EXHIBITORS/HELPER OF THIS EQUIPMENT WILL RESULT IN A FINE.
- Fire officers will be on duty on site at all times and any violations will be treated as serious offences.

14. VEHICLES

- All cars, trucks and horse boxes must during the period of the Show be parked in the allocated areas.
- It is the responsibility of all exhibitors to ensure that their vehicles are locked.
- Where applicable, make sure the batteries, fuel/diesel tanks are closed and locked.
- Exhibitors are requested to clearly display a contact number on their vehicles' dashboards at the Show should the Show Organisers need to contact them urgently.
- No vehicles will be permitted between the rows of stalls/stables, except for 1 (one) pick-up per exhibitor.
- The Show Organisers do not accept responsibility for any possible loss or damage of any exhibitors' property.
