7. Bulle moet vir die nodige geslagsiektes getoets wees en vir vrugbaarheid.
Vrugbaarheid en Trichomoniose sertifikate moet voor keuring aan die keurders die oorhandig word.

Herewith the entry forms for the National Braunvieh SA Sale. The Sale will take place on 23 September 2015 at the GWK Complex, Kimberley.

I would like to bring the following to your attention:

1. Entry fees will be R500.00 per bull, R300.00 for females and R100.00 for commercial animals.
2. **Male and female animals do not need to be halter tamed, but must be in show condition.**
3. Entry Fees must be included with the entry form and made payable to the Braunvieh SA Society.
4. All bulls on the Braunvieh SA Sale must have been branded.
5. Indexes must meet the minimum breed standards.
6. All animals will be screened before the sale on the farm. Try to do the inspection with annual inspection
7. Bulls must be tested for venereal diseases and for fertility.
Fertility and Trichomoniose certificates must be provided to the inspectors prior to inspection.

The draft catalogue will be sent to all sellers before printing. Each seller will have 48 hours
